

## CONVERSE COUNTY

### Demographics

The Census Bureau’s current census estimates indicate that Converse County’s population increased from 13,833 in 2010 to 14,191 in 2016, or by 2.6 percent. This compares to a statewide population change of 3.9 percent over the period. The number of people from 25 to 35 years of age increased by 8.5 percent, and the number of people from 55 to 64 years of age increased by 8.7 percent. The white population increased by 1.0 percent, while the black population increased by 103.7 percent. The Hispanic population increased from 867 to 1,152 people between 2010 and 2016 or by 32.9 percent. These data are presented in Table II.5.1, below.

Table II.5.2, on the following page, presents the population of Converse County by age and gender from the 2010 Census and 2016 current census estimates. The 2010 Census count showed a total of 7,017 males, who accounted for 50.7 percent of the population, and the remaining 49.3 percent, or 6,816 persons, were female. In 2016, the number of males rose to 7,186 persons, and accounted for 50.6 percent of the population, with the remaining 49.4 percent, or 7,005 persons being female.

At the time of the 2010 Census, there were 103 persons living in “group quarters.” This type of household is defined as places where individuals live or stay in a group living arrangement owned or managed by an organization that provides housing or services for residents, such as medical care. Group quarters also include places like college residence halls, military barracks, or correctional facilities. Between 2000 and 2010, the number of persons living in group quarters increased by 9.6 percent, as shown in Table II.5.3, below.

In the 1980, 1990, and 2000 decennial censuses, the Census Bureau released several tabulations in addition to the full SF1 100 percent count data including the one-in-six SF3 sample. These additional samples, such as the SF3, asked supplementary questions regarding income and household attributes that were not asked in the 100 percent count. In the 2010 decennial census, the Census Bureau did not collect additional sample data, such as the SF3, and thus many important housing and income concepts are not available in the 2010 Census.

<sup>102</sup> In the 2010 Census, “juvenile facilities” and “correctional facilities” were reported separately.

To study these important concepts the Census Bureau distributes the American Community Survey every year to a sample of the population and quantifies the results as one-, three- and five-year averages. The one-year sample only includes responses from the year the survey was implemented, while the five-year sample includes responses over a five-year period. Since the five-year estimates include more responses, the estimates can be tabulated down to the Census tract level, and considered more robust than the one or three year sample estimates.

Table II.5.4, below, shows data on household type by tenure in the 2015 5-year ACS data. Household type is broken down by family households and non-family households. In 2014, there were an estimated 4,034 family households, of which 3,203 housed married couple families and 831 housed “other families.” “Other family” is defined as either a male householder with no wife present, of whom there were 364 families, or a female householder with no husband present, of which there were 467 families. There were also an estimated 1,643 “non-family households,” which refers to households of unrelated people or one person living alone. When compared to the state, the percentage of family households in Converse County was 71.1 percent, which compared to the statewide rate of 64.9 percent. Of the family households in Converse County, 79.4 percent were married households, which compared to 79.7 percent in the State of Wyoming.

Table II.5.5, on the following page, displays the 2015 5-year ACS census data for household type by household size. In 2015, there were 2,113 two-person family households, 900 three-person family households and 541 four-person family households. One-person non-family households made up 92.8 percent of all non-family households or an estimated 1,524 households. Converse County’s two persons households made up 38.8 percent of total housing units and four person households made up an additional 9.8 percent, which compares to 38.2 and 11.3 percent, respectively, for the State of Wyoming.

The 2015 5-year ACS census estimates also provided information on tenure by household size. According to the 2015 ACS estimates, of the 2,204 two-person households, 1,862 were owner-occupied and 342 were renter-occupied. Of the 555 four-person households, 386 were owner-occupied and 169 were renter-occupied. Further household size data by tenure are presented in Table II.5.6, below.

As seen in Table II.5.7, on the following page, Converse County had a total of 6,478 housing units of which 5,677 or 87.6 percent were occupied. Of these occupied units, 74.5 percent, or 4,229

units were owner occupied, which compares to a statewide rate of 69.1. A total of 801 units or 12.4 percent of all units were vacant. This compared to a statewide vacancy rate of 14.9 percent.

Table II.5.8, below, shows that of the 801 vacant housing units in Converse County as reported in the 2015 ACS data, 174 or 21.7 percent were for rent and 159 or 19.9 percent were for sale. An estimated 196 units were for seasonal, recreational, or occasional use, and 195 or 24.3 percent of all vacant units were listed as “other vacant.” This compares to a statewide percentage of 27.5 percent for “other vacant” units.

Table II.5.10, on the following page, shows households by income for Converse County and the State of Wyoming. In Converse County, there were a total of 420 households or 7.4 percent with incomes under \$15,000 compared to 9.4 percent of households in Wyoming. There were another 695 households that had incomes between \$35,000 and \$49,999, which accounted for 12.2 percent of households and compared to 13.6 percent for the State of Wyoming. Households with incomes of \$100,000 or more accounted for 25.7 percent of total households and numbered 1,461 in Converse County.

Poverty statistics were also reported in the 2015 5-year ACS estimates, and these data are displayed in Table II.5.11, below. In total, the poverty rate in Converse County was 9 percent, which compared to a statewide poverty rate of 11 percent in Wyoming. The male population in Converse County had a poverty rate of 7 percent and the female population had a poverty rate of 12 percent. There were 59 males and 60 females in poverty under the age of 5. Overall, 9.1 percent of persons in poverty in Converse County were under the age of five, which compared to 12.0 percent statewide. The elderly population, comprised of individuals 65 years of older, had 193 individuals with incomes below the poverty level which represented 14.8 percent of the total population in poverty. In the State of Wyoming there were 5,008 individuals with incomes below the poverty level which represented 7.7 percent of the total Wyoming population in poverty.

Table II.5.12, on the following page, presents the breakdown of households by unit type and tenure. Between 2010 and 2015, Converse County saw an average of 3,462 owner-occupied

single-family units compared to 465 single-family rental units. In Converse County, single-family units comprised 69.2 percent of all households compared with 71.8 percent statewide. Converse County had a total of 403 apartment rental units and total apartment units accounted for 8.0 percent of all households. In the State of Wyoming, apartment units accounted for 8.7 percent of total households. There were also an estimated 966 mobile homes in Converse County, which comprised 17.0 percent of all occupied housing units and compared to 12.9 statewide.

Table II.5.13, on the following page, shows the number of households by year of construction. As shown, 10.1 percent, or 571 units, were built in 1939 or earlier in the county, and another 230 percent were built between 1940 and 1949. The number of households built between 2000 and 2009 was 656, which accounted for 11.6 percent of all households, and an additional 134 households, or 2.4 percent, were built in 2010 or later. These figures compare to 6,389 households, or 2.8 percent, that were built from 2010 or later statewide.

Table II.5.14, below, displays housing units for Converse County and the State of Wyoming. The number of rooms in Converse County varied between households. Households with one room accounted for only 2.2 percent of total housing units, while households with five and six rooms accounted for 22.4 and 17.2 percent, respectively. The median number of rooms in Converse County was 6 rooms, which compared to 6 statewide.

Table II.5.15, at right, shows the number of households in the county by number of bedrooms and tenure. There were 112 rental households with no bedrooms, otherwise known as studio apartments. Two-bedroom households accounted for 24.8 percent of total households in Converse County, which compared to 24.3 percent statewide. In Converse County, the 2,485 households with three bedrooms accounted for 43.8 percent of all households, and there were only 291 five-bedroom or more households, which accounted for 5.1 percent of all households.

The age of a structure influences its value. As shown in Table II.5.16, at right, structures built in 1939 or earlier had a median value of \$190,000, while structures built between 1950 and 1959 had a median value of \$169,200 and those built between 1990 to 1999 had a median value of \$166,200. The newest structures tended to have the highest values and those built between 2010 and 2013 had a median value of \$195,000. The total median value in Converse County was \$190,300, which compared to \$194,800 in the State of Wyoming.

Household mortgage status is reported in Table II.5.17, on the following page. In Converse County, households with a mortgage accounted for 59.9 percent of all households or 2,535 housing units, and the remaining 40.1 percent or 1,694 units had no mortgage. Of those units with a mortgage, 315 had either a second mortgage or home equity loan, 29 had both a second mortgage and home equity loan, and 2,191 or 86.4 percent had no second mortgage or no home equity loan.

The Wyoming driver’s license data provided by the WYDOT indicated a net decrease of 46 persons during the first half of 2017. The driver’s license total exchanges since 2000 for Converse County are presented below in Table II.5.19 and indicate a net increase of 1,272 persons over the time period.

**Economics**

The HUD estimated MFI for Converse County was \$76,700 in 2017.<sup>103</sup> This compares to Wyoming’s MFI of \$74,700. Diagram II.5.1, below, illustrates the estimated MFI for 2000 through 2017.

 HUD Data: 2000-2017

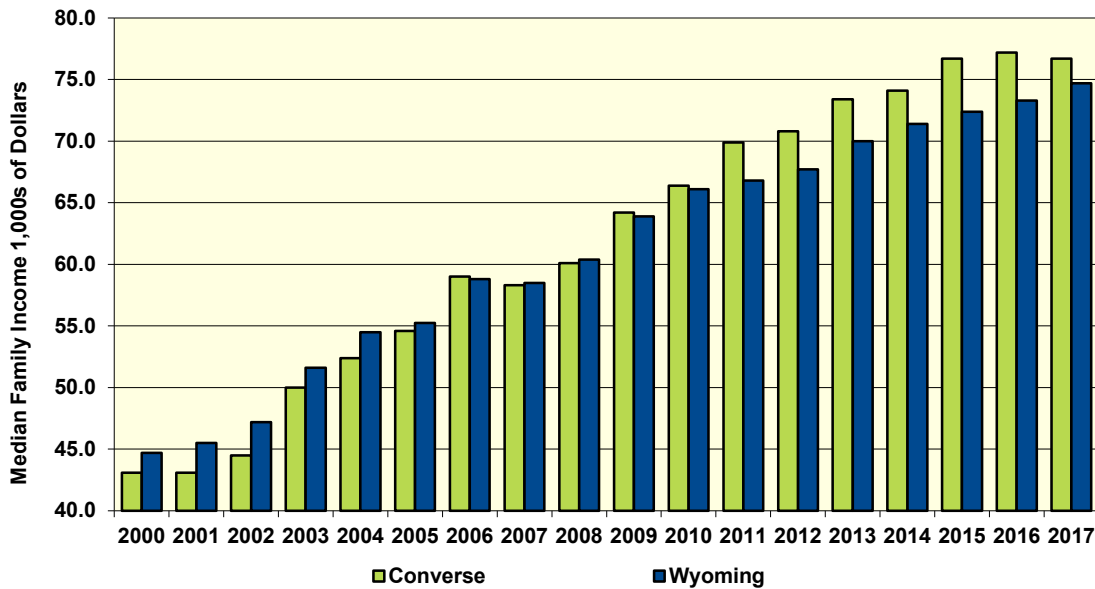


Table II.5.20, on the following page, shows the labor force statistics for Converse County from 1990 to the present. Over the entire series the lowest unemployment rate occurred in 2007 with a rate of 2.8 percent. The highest level of unemployment occurred during 2016 rising to a rate of 6.2 percent. This compared to a statewide low of 2.8 percent in 2007 and statewide high of 6.4 percent in 2010. Over the last year the unemployment rate in Converse County increased from 3.6 percent in 2015 to 6.2 percent in 2016, which compared to a statewide increase to 5.3 percent.

 1990 – 2016 BLS Data

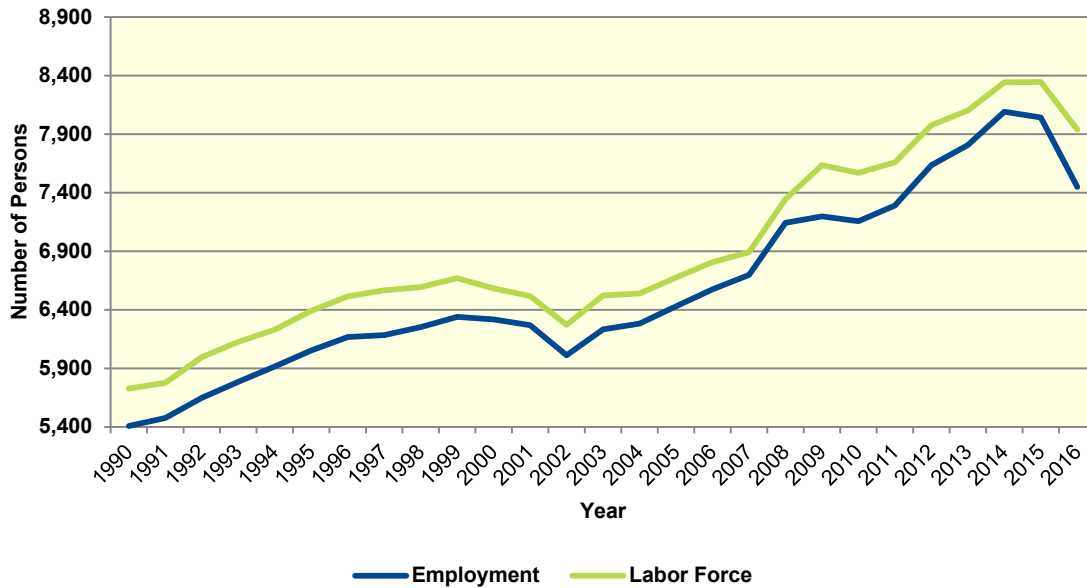
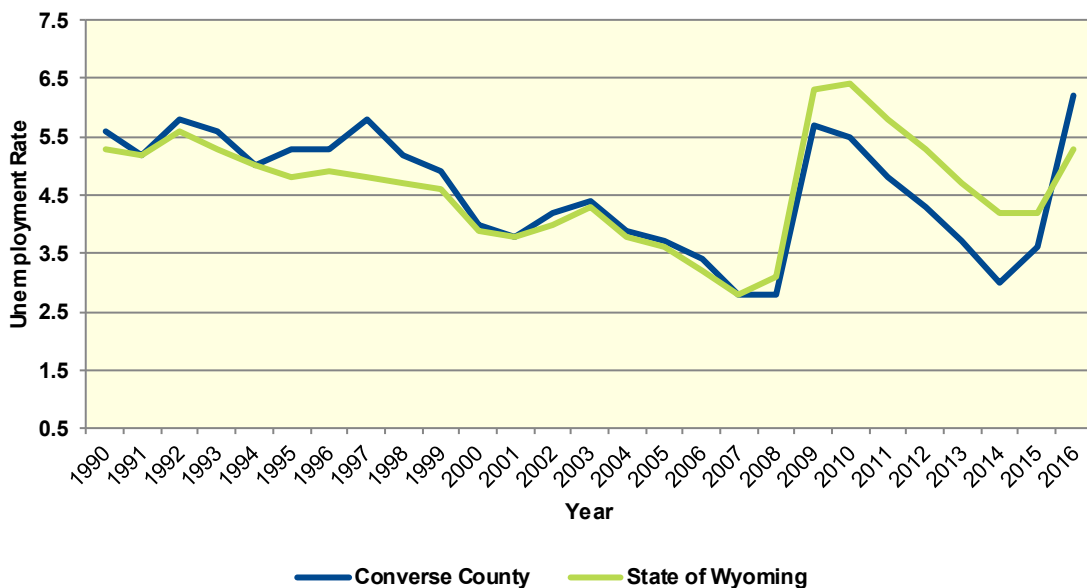


Diagram II.5.3 below shows the unemployment rate for both the state and Converse County. During the 1990s the average rate for Converse County was 5.4 percent, which compared to 5 percent statewide. Between 2000 and 2010 the unemployment rate averaged of 3.9 percent over the decade, which compared to 3.9 statewide. Since 2010 the average unemployment rate was 4.4 percent. Over the course of the entire period Converse County had an average unemployment rate lower than the state, 4.5 percent for Converse County, versus 4.6 statewide.

The BLS produces the Quarterly Census of Employment and Wages (QCEW), which reports monthly data on employment and quarterly data on wages and number of business establishments. QCEW employment data represent only filled jobs, whether full or part-time, temporary or permanent, by place of work the pay period. Data from this series are from the period of January 2005 through December 2016 and are presented in Table II.5.21, below, with the 2016 information considered preliminary (p). Between 2015 and 2016, total annual employment decreased from 6,460 persons in 2015 to 5,792 in 2016, a change of 10.3 percent.

The Bureau of Economic Analysis (BEA) measures employment, defined as the total number of full- and part-time jobs by place of work. In 2015, the most recent year for which data are available, Converse County recorded 9,594 jobs. Total real personal income, comprising all wage and salary earnings, proprietorship income, dividends, interest, rents, and transfer payments, adjusted for place of residence, was \$783,156,000, and real per capita income was \$55,012 in 2015. This compares to a statewide average real per capita income of \$56,081. The average earnings per job in the county was \$58,277 in 2015, while Wyoming average earnings per job was \$53,875. These data are presented in full in **Volume II. Technical Appendix.**

**Housing**

According to the Wyoming cost of living index, real average apartment rent in Converse County decreased from \$785 in fourth quarter 2015 to \$608 in fourth quarter 2016, or by 22.6 percent. During the same period, detached single-family home rents decreased by 17.0 percent, rents for mobile homes on a lot decreased by 11.2 percent, and rents for mobile home lots decreased by 1.3 percent.

Converse County rental prices experienced average annualized increases of 0.1 percent for apartments, 0.7 percent for houses, 1.3 percent for mobile homes plus a lot, and -0.4 percent for mobile home lots since second quarter 1986 through fourth quarter 2016. These figures compare to state average annualized increases in rental prices of 0.8 percent for apartments, 1.2 percent for houses, 1.0 percent for mobile homes plus a lot, and 0.9 percent for mobile home lots over the same period. Table II.5.24, at right, presents the Converse County data for each rental type.

The Census Bureau reports building permit authorizations and “per unit” valuation of building permits by county annually. Single-family construction usually represents most residential development in the county. Single-family building permit authorizations in Converse decreased from 30 authorizations in 2015 to 3 in 2016.

The real value of single-family building permits increased from \$208,227 in 2015 to \$256,667 in 2016. This compares to an increase in permit value statewide, with values rising from \$353,167 in 2015 to \$353,422 in 2016. Additional details are given in Table II.5.25, below.

The average sales price of existing, detached, single-family homes was provided by the Department of Revenue (DOR). In 2016, the average sales price in Converse County was \$209,669. This represented a decrease of 7.1 percent from the previous year. Wyoming’s average was \$280,428, an increase of 1.7 percent over the previous year. The Wyoming Rental Vacancy Survey (RVS) has been completed biannually since 2000, with the most recent survey conducted in June 2017.<sup>104</sup> During June 2017, a total of 48 surveys were completed by property managers in Converse County. Of the 708 rental units surveyed, 92 were vacant, indicating a vacancy rate of 13.0 percent, as shown in Table II.5.27, at right. This compares to an 13.0 percent vacancy rate one year ago and a June 2017 statewide vacancy rate of 10.2 percent.

Diagram II.5.4, on the following page, shows the historical vacancy rate for Converse County and Wyoming. As can be seen, the vacancy rate in Converse County has been generally lower than statewide vacancy rate but has spiked in recent surveys on account of the decrease in oil prices and production.

 RVS Data, June 2001 - June 2017

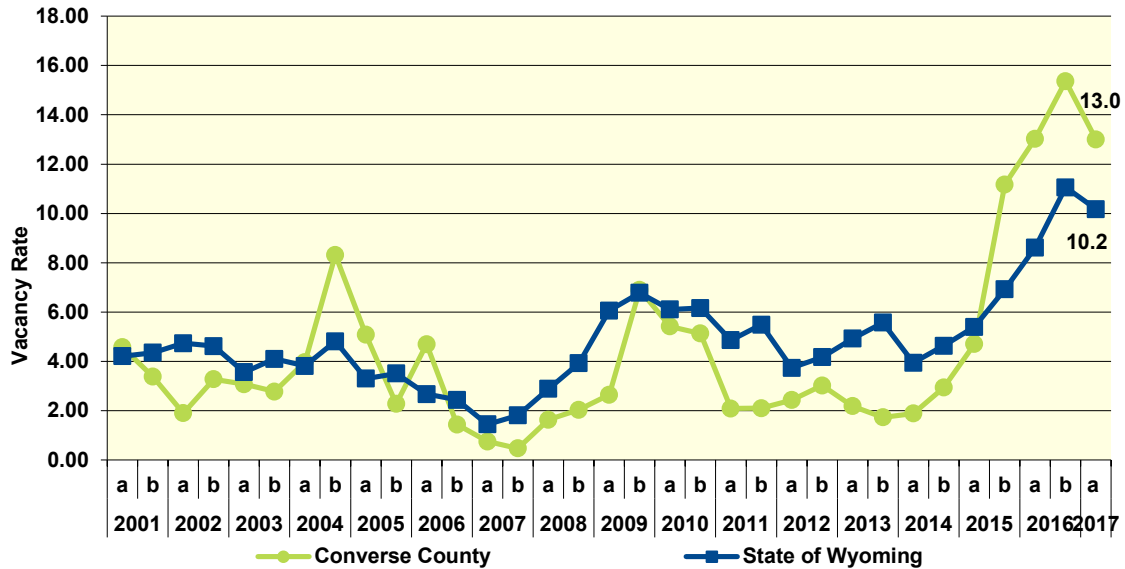

 RVS Data, June 2006 – June 2017

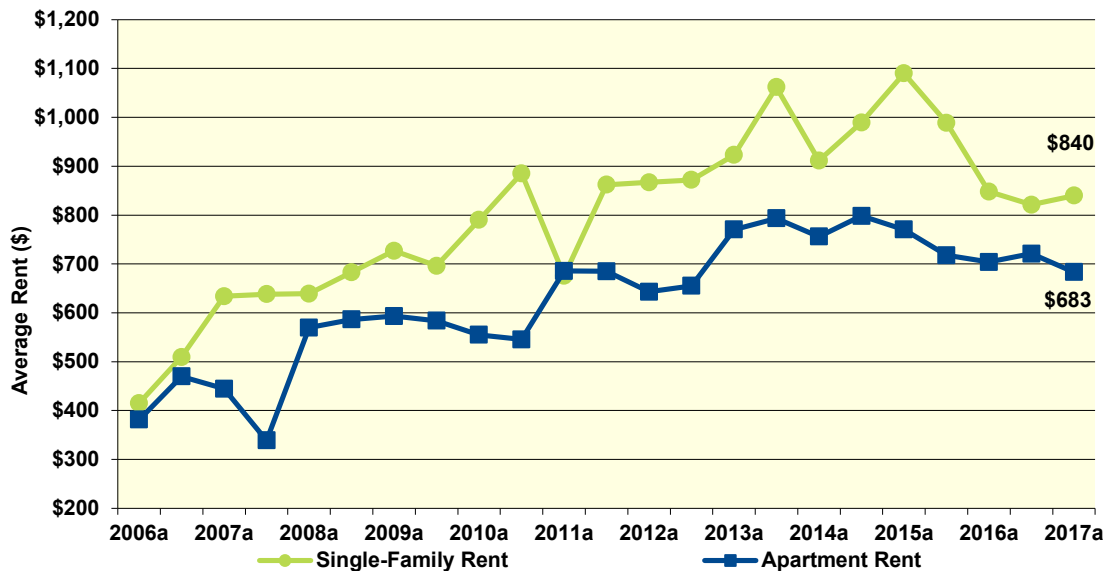


Table II.5.28 below shows the amount of total and vacant units by unit type, with their associated vacancy rates. At the time of the survey, there were an estimated 43 single family units in Converse County, with 6 of them available. This translates into a vacancy rate of 14.0 percent in Converse County, which compares to a single family vacancy rate of 5.8 percent for the State of Wyoming. There were 526 apartment units reported in the survey, with 57 of them available, which resulted in a vacancy rate of 10.8 percent. This compares to a statewide vacancy rate of 11.2 percent for apartment units across the state.

Table, II.5.39, below, shows the most common answers from the 2017 fiscal year Housing Needs Assessment (HNA) Survey. This survey focused on new Wyoming residents and was conducted over the phone using a sample from data provided by the WYDOT. Converse County had a total of 5 respondents, with an average persons per household of 2.2 people. Of new residents to Converse County, 60.0 percent were married and the most common age group arriving in the state was 45 to 54 years old. Most new residents moved for a job transfer.

The HNA survey, also asked residents about their current residence. New residents most commonly reported living in a single family home, with 60.0 percent of respondents owning thier residence. The average mortgage payment in Converse County was \$1,150 and the average rent was \$500. When asked if they were satisfied with their current housing, 100.0 percent said they were satisfied with thier current housing.

## Housing Problems

While the ACS data do not report significant details regarding the physical condition of housing units, some information can be derived from data relating to overcrowding, incomplete plumbing or kitchen facilities, and cost burdens.

Overcrowding is defined as having from 1.1 to 1.5 people per room per residence, with severe overcrowding defined as having more than 1.5 people per room. According to 2015 5-year ACS data, 180 or 3.2 percent of households in Converse County were overcrowded and another 46 or 0.8 percent of units were severely overcrowded, as shown in Table II.5.40, below. This housing problem was far more prevalent in renter households as compared to owner households.

Incomplete plumbing and kitchen facilities are another indicator of potential housing problems. According to the Census Bureau, a housing unit is classified as lacking complete plumbing facilities when any of the following are not present: piped hot and cold water, a flush toilet, and a bathtub or shower. Likewise, a unit is categorized as deficient when any of the following are missing from the kitchen: a sink with piped hot and cold water, a range or cook top and oven, and a refrigerator.

At the time of the 2015 5-year ACS, a total of 155 units or 2.4 percent of all housing units in Converse County were lacking complete kitchen facilities. This compared to 2.6 percent of households statewide without complete kitchen facilities. These data are presented in Table II.5.41, at right.

The third type of housing problem reported in the 2015 ACS data is cost burden. Cost burden is defined as gross housing costs that range from 30.0 to 50.0 percent of gross household income; severe cost burden is defined as gross housing costs that exceed 50.0 percent of gross household income. For homeowners, gross housing costs include property taxes, insurance, energy payments, water and sewer service, and refuse collection. If the homeowner has a mortgage, the determination also includes principal and interest payments on the mortgage loan. For renters, this figure represents monthly rent and selected electricity and natural gas energy charges.

In Converse County, 12.9 percent of households had a cost burden and 5.2 percent of households had a severe cost burden, which compared to 14.3 percent with a cost burden and 9.5 percent with a severe cost burden in the State of Wyoming. Roughly 14.1 percent of homeowners with a mortgage in Converse County experienced a cost burden and 7.3 percent experienced a severe cost burden, while 22.1 percent of renters had a cost burden and 3.6 percent had a severe cost burden, as seen in Table II.5.43, on the following page.

**2017 WCDA Loan Profile**

The Wyoming Community Development Authority (WCDA) began purchasing home loans in 1978 to provide affordable housing in Wyoming. There were a total of 1,372 loans purchased in Converse County between 1979 and 2017, with 4 occurring in fiscal 2017. The average home size over the period was 1,138 square feet and 1,121 square feet in fiscal 2017. For homes receiving a WCDA loan in fiscal 2017, the average year a home was built was 1990. The average household income in fiscal 2017 in nominal terms, without the effects of inflation being taken into consideration, was \$41,274. The average purchase price in fiscal 2017 was \$191,600. In fiscal 2017, 0.0 percent of loans purchased were for new construction, and 0.0 percent had female heads of household. Fiscal year data for the entire operating history of the WCDA can be found in **Volume II. Technical Appendix.**

Converse County saw a 14 percent reduction in population, which was tied for the third highest county population decline in the State.<sup>105</sup> As a result, the County school is facing funding cuts due to the decrease in enrollment.<sup>106</sup> Although the energy economy in Wyoming has been experiencing a decline, the Wyoming Oil and Gas Conservation Commission approved 24 new oil/gas drilling permits in Converse County in just the first two weeks of 2017.<sup>107</sup>
